WHEREAS, the California Department of Public Health (CDPH), has made funds available to local health departments for the California Home Visiting Program (CHVP) State General Funds (SGF) Evidence-Based Home Visiting (EBHV) for the Fiscal Year 2023-2024; and

WHEREAS, it is in the best interest of the residents of the County of Yuba to accept and utilize the allocated funds to establish an evidence based home visiting program. Home visiting is a proactive intervention focused on promoting positive parenting and child development. The CHVP targets families overburdened by inadequate income, unstable housing, and low education levels who may experience higher rates of Adverse Childhood Experiences (ACEs). This includes experiences like child maltreatment, substance use disorder, and mental health related issues.

WHEREAS, CDPH has allocated Yuba County funds in the amount of \$481,574 for the term of July 1, 2023 through June 30, 2024.

NOW, THEREFORE, BE IT RESOLVED, the Yuba County Board of Supervisors hereby authorizes the Director of HHSD to submit required documents to CDPH for the CHVP SGF EBHV program and to accept the allocated funding and any subsequent funds allocated for Fiscal Year 2023-2024


BE IT FURTHER RESOLVED by the Yuba County Board of Supervisors that the Director of the HHSD is hereby authorized to: execute, subject to review and approval of County Counsel, all documents as required by the CHVP SGF EBHV funding for the Fiscal Year 2023-2024 including subsequently extended term, execute agreements, memorandums of understanding (MOUs) or amendments developed under the CHVP SGF EBHV funding, including but not limited to amendments for additional or lesser funding; and accept, transfer and allocate all CHVP SGF EBHV funds and any subsequent funds allocated for the stated period.

A copy of the executed agreements, MOUs or any amendments thereto shall be filed in the office of the Clerk of the Board.
