**WHEREAS**, the Sheriff's Department, including its Animal Care Services Division, has historically partnered with the Yuba County Mounted Sheriff's Posse (also known as the Yuba County Search and Rescue) for use of the Posse arena, located at 5396 Marysville Road in Browns Valley, to house livestock and other animals; and

**WHEREAS**, this location is equipped with a large arena/run area for livestock, as well as livestock stalls, troughs, and other materials and equipment to properly care for large animals and livestock; and

**WHEREAS**, the Yuba County Mounted Sheriff's Posse arena and evacuation center has also currently and historically provided shelter and operates as an evacuation center for residents with livestock and large animals during emergencies and wildfire evacuations; and

**WHEREAS**, the Yuba County Mounted Sheriff's Posse is a volunteer-based organization and is funded exclusively by donations, fundraisers, and grants from the community; and

**WHEREAS**, no other costs shall be incurred through this agreement, other than standard operating costs for the Sheriff's Department and Animal Care Services for its own administration and maintenance expenses, including but not limited to employees, feed, hay, supplies, equipment and miscellaneous fees.

**NOW, THEREFORE, BE IT RESOLVED** that the Yuba County Board of Supervisors hereby approves the arena use agreement between the Yuba County Sheriff's Department and Yuba County Mounted Sheriff's Posse, and authorizes Chair to execute.

**BE IT FURTHER RESOLVED**, that the Yuba County Board of Supervisors authorizes the Sheriff or authorized designee to execute all documents necessary to administer, monitor, and enforce this arena use agreement to utilize the arena for rescued and evacuated large animals and livestock, subject to approval by County Counsel.






