RESOLUTION NO. 2023-089

WHEREAS, California Health and Safety Code (H&SC) Sections 121450, 121451 and 121452, authorize the California Department of Public Health (CDPH) Tuberculosis Control Branch (TBCB) to distribute, for the purpose of tuberculosis (TB) control, an annual subvention. This subvention is paid quarterly to any local health department that maintains a TB control program consistent with the standards and procedures established by the CDPH TBCB; and

WHEREAS, the purpose of TB local assistance funds is to assist the current efforts of local TB programs to prevent, control, and eventually eliminate TB in California; and

WHEREAS, it is in the best interest of the residents of the County of Yuba to accept the funding to address the TB needs in the community while adhering to all requirements as described in the Tuberculosis Control Local Assistance Funds Standards and Procedures Manual for Fiscal Year 2023-2024.

NOW, THEREFORE, BE IT RESOLVED, the Yuba County Board of Supervisors hereby authorizes the Director of HHSD to submit required documents to CDPH for the Enhanced Prevention and Control funding and to accept the allocated funding and any subsequent funds allocated for the period of July 1, 2023 through June 30, 2024.

BE IT FURTHER RESOLVED by the Yuba County Board of Supervisors that the Director of the HHSD is hereby authorized to: execute, subject to review and approval of County Counsel, all documents as required by the Enhanced Prevention and Control funding for the Fiscal Year 2023-2024 including subsequently extended term, execute agreements, including but not limited to amendments for additional or lesser funding; and accept, transfer and allocate all Enhanced Prevention and Control funds and any subsequent funds allocated for the stated period.

A copy of the said agreements, MOUs or any amendments thereto, shall be filed in the office of the Clerk of the Board, County of Yuba.


