**WHEREAS**, The California Department of Public Health (CDPH) has made Future of Public Health (FoPH) funds available under the California Budget Act of 2022 (Health and Safety Code 101320-101320.5) to Local Health Jurisdictions (LHJs); and

**WHEREAS**, it is in the best interest of the residents of the County of Yuba to accept and utilize the allocated funds to further develop and strengthen the public health workforce and infrastructure; and

**WHEREAS**, CDPH allocated Yuba County FoPH funds of \$707,793 per Fiscal Year for the term of July 1, 2023 through June 30, 2026.

**NOW, THEREFORE, BE IT RESOLVED** the Yuba County Board of Supervisors hereby authorizes the HHSD Director to submit required documents to CDHP for the FoPH funding and to accept the allocated funding and any subsequent funds allocated for FYs 2023-2026.

**BE IT FURTHER RESOLVED** by the Yuba County Board of Supervisors that the Director of the Health and Human Services Department (HHSD) is hereby authorized to: accept, transfer, and administer allocated funds from the California Department of Public Health (CDPH) through its Future of Public Health (FoPH) program for the period of July 1, 2023 through June 30, 2026, including any subsequently extended terms, and to execute, subject to review and approval of County Counsel, all documents as required by the FoPH funding, including any amendments for additional or lesser funding; for the stated period.

A copy of the executed agreements, MOUs or any amendments thereto shall be filed in the office of the Clerk of the Board.




