**RESOLUTION NO. 2023-094**

**WHEREAS**, the California Department of Social Services ("CDSS") has made funds available to establish, continue, and expand housing and homelessness assistance through the California Work Opportunity and Responsibility to Kids ("CalWORKs") Housing Support Program ("HSP"); and

**WHEREAS**, the CalWORKs HSP is intended to foster housing stability for families experiencing homelessness or at risk of homelessness in the CalWORKs program; and

**WHEREAS**, the CDSS has Fiscal Year ("FY") 2023-24 Noncompetitive Allocation funding available for all fifty-eight (58) counties. Counties must sign and submit a Director's Certification, complete a Budget Template, and if applicable an Expenditure Explanation to accept these funds, which do not have a match requirement; and

**WHEREAS**, Noncompetitive Allocation funding not accepted by way of a completed Director's Certification, including funds declined by a county will be allocated to counties that indicate they can accept additional funds, as indicated in the Director's Certification; and

**WHEREAS**, the CDSS has allocated \$1,395,483 of CalWORKs HSP FY 2023-24 Noncompetitive Allocation funding to Yuba County; and

**WHEREAS**, the HHSD Director seeks to submit a Director's Certification and other required documents to accept Yuba County's CalWORKs HSP FY 2023-24 Noncompetitive Allocation funding; and

**NOW, THEREFORE, BE IT RESOLVED** by the Yuba County Board of Supervisors that the HHSD Director is authorized to submit a Director's Certification and other required documents for Yuba County's CalWORKs HSP FY 2023-24 Noncompetitive Allocation funding and any subsequent funds allocated.

**BE IT FURTHER RESOLVED** by the Yuba County Board of Supervisors that the HHSD Director is hereby authorized to: execute, subject to review and approval of County Counsel, all documents as required by the Certifications and the resultant allocations for the term of July 1, 2023 through June 30, 2025 including subsequently extended term; execute amendments developed under the CalWORKs HSP, including but not limited to amendments for additional or lesser funding; and accept, transfer and administer all CalWORKs HSP funds and any subsequent funds allocated for the stated period.

A copy of the said agreements or any amendments thereto shall be filed in the office of the Clerk of the Board, County of Yuba.




