**WHEREAS**, on July 11, 2023, the Board of Supervisors of the County of Yuba adopted Resolution number 2023-057 formally adopting the Classification System – Basic Salary / Hourly Schedule effective July 1, 2023; and

**WHEREAS**, on December 31, 2023, the elected Treasurer-Tax Collector, Dan Mierzwa, resigned his office; and

**WHEREAS**, the Board of Supervisors authorized the Human Resources Department to conduct a recruitment to fill the resulting vacancy; and

**WHEREAS**, on February 27, 2024, the Board of Supervisors authorized the Human Resources Department to increase the Treasurer-Tax Collector salary to align with internal and external market data by establishing the base salary of \$11,152 that is subject to the County’s Elected Longevity Step Index Table, which amounts to a monthly minimum salary of \$13,561; and

**WHEREAS**, the Board of Supervisors now intends to amend Resolution No. 2023-057, the Classification System – Basic Salary/Hourly Schedule as it relates to the salary adjustment of the elected position Treasurer-Tax Collector, effective April 1, 2024.


