WHEREAS, on September 12, 2023, the Board of Supervisors of the County of Yuba adopted Resolution No. 2023-072 formally adopting the Departmental Position Allocation Schedule effective July 1, 2023; and

WHEREAS, Human Resources contracted with Municipal Resource Group (MRG), to conduct a class and compensation study of Employment & Training Specialist I/II and their supervisor, a Social Worker Supervisor I within the Health & Human Services Department; and

WHEREAS, on February 26, 2024, MRG provided a report of their findings to Human Resources which included reclassifying existing position allocations to the new classifications of HHS Education Specialist and HHS Education Supervisor; and

WHEREAS, The Human Resources Department, the union, and the Health & Human Services Department concur with MRG's recommendations to reclassify the position allocations of Employment & Training Specialists to HHS Education Specialists and the YubaWORKs Social Worker Supervisor I to HHS Education Supervisor; and

WHEREAS, the Human Resources Department and the Health & Human Services Department concur with MRG's findings and recommendations and propose establishing new classifications titled HHS Education Specialist and HHS Education Supervisor and reclassifying the Employment & Training Specialists and the Social Worker Supervisor I in YubaWORKs to the new classifications accordingly; and

WHEREAS, the Board of Supervisors now intends to amend Resolution No. 2023-072 as it relates to the Departmental Position Allocation Schedule for the Health & Human Services Department.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors that Resolution No. 2023-072 be and hereby is amended as it relates to the Health & Human Services Department.
