1) **Major Conditional Use Permit CUP 2022-0001 (Pine Tree RV Campground)**: The applicant is requesting to establish a new 50 space RV campground. Each RV space will be at least 1,000 sq ft in size and will allow room for one recreational vehicle. Accessory uses such as a store and pickle ball courts are proposed. The project is located across from the intersection of Jaynes Lane and Marysville Road in the Camptonville community. The project property is located at 14566 Marysville Road in the community of Camptonville (APN: 064-070-025). The 2030 General Plan designates the land use as Rural Community and the zoning designation as Rural Commercial.
