SUBJECT: Presentation of the Community Health Assessment in response to the County's Strategic Priorities

RECOMMENDATION: It is recommended that the Board of Supervisors receive a presentation about the Community Health Assessment in response to the County's Strategic Priorities.

BACKGROUND: Approximately 5 months ago, the Board of Supervisors adopted Strategic Plan Priorities. Over the last several months, the strategic priorities have been a focal point for the HHS staff as they develop annual budgets, work plans, and provide daily services to the public.

DISCUSSION: This presentation about the Community Health Assessment is in direct response to sections pertaining to Health. This presentation addresses the Board of Supervisors request for additional information from the Yuba County Health and Human Services Public Health Division identifying the areas of concern, what programs and services are in place to address them and recommendations to improve overall health of the County. The Yuba County Interim Health Officer and the Chief Executive Officer of Peach Tree Clinic have worked in collaboration to bring this presentation to the Board.
