RESOLUTION NO. 2022-244

WHEREAS, the Workforce Innovation and Opportunity Act (WIOA) became effective July 1, 2015. Per State of California Department of Social Services All County Letter No. 16-51, Yuba County is required to partner with Americas Job Centers of California, also known as One Stop Centers.;

WHEREAS, Yuba County has continuously joined together with Sutter, Colusa and Glenn Counties to form the North Central Counties Consortium (NCCC) for the administration of WIOA programs and services;

WHEREAS, this Consortium has created an opportunity for us to build successful collaboration assisting CalWORKs participants to become trained, employed, and self-sufficient.

WHEREAS, it is in the best interest of the County to continue this collaboration as it benefits the community we serve with services, such as, coordinated education, training and workforce development services that improve long-term employment outcomes for individuals receiving assistance, offered by the One Stop.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Yuba that the HHSD Director is hereby authorized to execute, upon review and approval of County Counsel, documents as required by the program for the stated period of July 1, 2022 to June 30, 2025: the HHSD Director is granted authority to execute

agreements, amendments or memorandums of understanding developed under this resolution.

A copy of the said agreements, memorandums of understanding, and any amendments thereto, shall be filed in the office of the Clerk of the Board, County of Yuba.




