RESOLUTION NO. 2022-252

WHEREAS, in February 2022, the Yuba County Board of Supervisors awarded a two-year landscape maintenance service agreement to Botanica Landscapes; and

WHEREAS, the agreement with Botanica Landscapes was terminated early, at the end of August 2022, due to unresolvable performance issues; and

WHEREAS, an emergency service agreement with Elite Service Experts was executed by the Director of Public Works on September 1, 2022 and later ratified by motion by the Board of Supervisors in item 448/2022 at a public meeting held on September 13, 2022; and

WHEREAS, the emergency service agreement with Elite Service Experts commenced on September 1, 2022, with a termination date of December 31, 2022, plus the option of two (2) additional one (1) month term extensions; and

WHEREAS, Yuba County staff are currently in the process of procuring a new two-year agreement for landscape services to replace the emergency service agreement; and

NOW, THEREFORE, BE IT RESOLVED, the Yuba County Board of Supervisors hereby delegates authority to the Director of Public Works to execute or otherwise exercise in writing the term extension options contained in the emergency services agreement with Elite Service Experts attached hereto; and

BE IT FURTHER RESOLVED, the Yuba County Board of Supervisors hereby delegates authority to the Director of Public works to execute an amendment to the attached emergency services agreement with Elite Service Experts to extend the duration of the term of the emergency services agreement up to but not to exceed April 1, 2023.
