WHEREAS, the Regional Housing Authority (RHA) has made Tenant Protection Vouchers available to eligible youth under the Foster Youth to Independence Initiative (FYI) funded by the US Department & Urban Housing (HUD). The MOU will provide the framework for services, effective collaboration and timely communication among RHA, Yuba County Health and Human Services Department (YCHHSD), Sutter-Yuba Homeless Consortium (SYHC), and the RHA's voucher recipients; and

WHEREAS, it is in the best interest to administer the voucher program locally, provide applicant housing assistance, establish local preferences for selecting applicants for its voucher program, and assist applicants through the housing assistance process. The goal is to connect eligible youth ages 18 to 24 aging out of foster care, or with histories of involvement with foster care, and are at high risk of homelessness; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors that the HHSD Director is hereby authorized to enter into an agreement with the RHA and SYHC regarding the provision of Tenant Protection Vouchers for the Foster Youth to Independence Initiative at no cost to the County of Yuba for the period of 3 years; and

BE IT FURTHER RESOLVED, that the HHSD Director is hereby authorized to execute pertinent documents as may be required under the terms of the MOU; and

BE IT FURTHER RESOLVED, to the extent any contracts and/or agreements need to be amended and/or executed as a result of the award of Tenant Protection Vouchers to the County of Yuba, all such amendments and executions will be subject to County Counsel review.


