RESOLUTION NO. 2020-20

WHEREAS, California’s Homeless Coordinating and Financing Council within California’s Business, Consumer Services and Housing Agency (Agency) has made grant funds available for the Homeless Housing, Assistance, and Prevention (HHAP) Program; and

WHEREAS, the HHAP Program, established under Assembly Bill 101 (Committee on Budget, Chapter 159, Statutes of 2019), is a block grant program designed to provide jurisdictions with one-time grant funds to support regional coordination and expand or develop local capacity to address their immediate homelessness challenges; and

WHEREAS, spending must be informed by a best-practices framework focused on moving homeless individuals and families into permanent housing and supporting the efforts of those individuals and families to maintain their permanent housing; and

WHEREAS, applicants must submit an application for HHAP Program funds in order to receive their allocation; and

WHEREAS, applicants submitting an application acknowledge that they are applying for the total amount of funds to which they are eligible for, which is calculated based on the U.S. Department of Housing and Urban Development’s official 2019 Point-in-Time (PIT) count; and

WHEREAS, Yuba County’s HHAP Program grant allocation is \$467,092.48; and

WHEREAS, the Director of the Health and Human Services Department seeks to apply for and be allocated HHAP Program grant funds for Yuba County in the amount of \$467,092.48; and

WHEREAS, the Agency has estimated that they will award all HHAP Program funds by April 1, 2020. Any funds not applied for and awarded will be released for a second round Notice of Funding Availability on a date to be determined by the Agency.

NOW, THEREFORE, BE IT RESOLVED, that the Yuba County Board of Supervisors hereby authorizes the Director of the Health and Human Services Department to submit an application on behalf of Yuba County for HHAP Program grant funds.

BE IT FURTHER RESOLVED by the Yuba County Board of Supervisors that the Director of the Health and Human Services Department is hereby authorized to: execute, subject to review and approval of County Counsel, all documents as required by the application and the resultant allocation for the period of July 1, 2019 through June 30, 2025; to execute agreements, memorandums of understanding (MOUs) or amendments developed according to the terms of the HHAP Program, including but not limited to amendments for additional or lesser funding; and to accept, transfer and allocate all HHAP Program funds for the stated six year period. A copy of the executed agreement, MOU or any amendment thereto shall be filed in the office of the Clerk of the Board.


