**WHEREAS**, the State of California has made grant funds available for the HIV/AIDS Surveillance Program, and

**WHEREAS**, the Public Health Division of the Yuba County Health and Human Services Department (HHSD) is ideally suited to provide such services for the residents of Yuba County; and

**WHEREAS**, the Director of the Health and Human Services Department (HHSD) on behalf of the County of Yuba applied for and was awarded \$30,075 in funds as a result of the application; and

**WHEREAS**, it is in the best interest of efficient and effective county government to have a Resolution of the Board of Supervisors authorizing HHSD Director to execute all resultant HIV Surveillance Program documents and to accept transfer and allocate funds in accordance with the terms of the HIV Surveillance Program.

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of Supervisors of the County of Yuba that the Health and Human Services Department is hereby authorized to enter into Agreement with the California Department of Public Health (CDPH) for HIV Surveillance Program funds.

**BE IT FURTHER RESOLVED**, by the Board of Supervisors of the County of Yuba that the HHSD Director is hereby authorized to accept, transfer and allocate \$30,075 for the five year period from July 1, 2019 through June 30, 2024 and any subsequent funds awarded for the stated period, in accordance with the terms of the HIV Surveillance Program

**BE IT FURTHER RESOLVED**, that the HHSD Director is hereby authorized to execute, upon review and approval of County Counsel, any and all documents as required by and in accordance with the terms of the HIV Surveillance Program.

**BE IT FURTHER RESOLVED**, that the HHSD Director is hereby authorized to execute agreements, amendments, or memorandums of understanding required to further the intent of this grant, upon review and approval of County Counsel.


A copy of said agreements and any amendments thereto, shall be filed in the office of the Clerk of the Board, County of Yuba.


