**WHEREAS**, the California Department of Housing and Community Development (the “Department” or “HCD”) has issued a Notice of Funding Availability (“NOFA”) for the Community Development Block Grant Program (“CDBG”), made available from the U.S. Department of Housing and Urban Development (“HUD”). The federal Small Cities CDBG program is authorized by the Housing and Community Development Act of 1974 (“HCDA”) as amended and codified at Title 42 United States Code (U.S.C.) §5301 et. seq., and Subpart 1 of the Federal CDBG Regulations, found at Title 24 Code of Federal Regulations (CFR) §570.480. The requirements of the State of California CDBG Program are in California Health and Safety Code (HSC) §§50825-50834; and

**WHEREAS**, in response to the 2019-2020 NOFA the County of Yuba, a political subdivision of the State of California (Applicant), wishes to submit an application to HCD to apply for and receive an allocation of CDBG Program funds up to the amount \$3,500,000.00, as described in APPENDIX D attached hereto and made a part of herein; and if selected, the execution of a standard agreement, any amendments thereto from the 2019-2020 funding year, and any related documents necessary to participate in the State CDBG Program; and

**WHEREAS**, Program Income funds in the amount up to \$400,000 will be utilized as part of the planning activity in the NOFA application, to cover pre-agreement planning costs; and

**WHEREAS**, loan guidelines and other procedural documents pertaining to gap financing activities will be established by the County's Community Development Block Grant (CDBG) Loan Review Committee; and

**WHEREAS**, pursuant to CDBG regulations, the public has been invited to comment on the proposed "CDBG NOFA Application" during a noticed public hearing, as well as to submit written comments; and

**NOW, THEREFORE, BE IT RESOLVED**, the Yuba County Board of Supervisors hereby declare:

*Section 1.* That the above recitals are all true and correct.

*Section 2.* That the County of Yuba shall submit to HCD an application to participate in the 2019-2020 Community Development Block Grant Program Notice of Funding Availability (NOFA).

*Section 3.* That the County of Yuba shall utilize Program Income Reuse funds as part of the planning activity in the CDBG NOFA application.

*Section 4.* That if the application for funding is approved, the County agrees to use the CDBG funds for eligible activities in the manner presented in the application as approved by HCD and in accordance with program regulations cited above including any and all other instruments necessary or required by HCD for participation in the CDBG Program.

Section 5. That the Board of Supervisors delegates to the Director of CDSA the authority, to execute in the name of the County of Yuba, the application, the Standard Agreement, and all other documents required by HCD for participation in the CDBG Program, and any amendments thereto that are consistent with the programs regulations and grant application; including the authorization to sign any and all procedural documents, subject to Counsel review, established by the CDBG Loan Committee.

Section 6. This Resolution shall take effect upon its adoption.




