RESOLUTION NO. 2020-40

WHEREAS, the California Department of General Services (“CDGS”) has made funds available to continue or implement the COVID-19 Emergency Homelessness Services; and

WHEREAS, the COVID-19 Emergency Homelessness Funding Award, established under Senate Bill (SB) 89 pursuant to the provisions of Section 36.00, Chapter 2 Statutes of 2020, aims to protect the health and safety of people experiencing homelessness and reduce the spread of the COVID-19 outbreak; and

WHEREAS, counties must submit a standard agreement and request COVID-19 Emergency Homelessness funds in an amount sufficient to meet their need, while considering their capacity to utilize the funds; and

WHEREAS, state COVID-19 Emergency Homelessness funds to receiving counties are available for expenditure upon approval from the CDGS Business, Consumer Services and Housing Agency (BCSH) through June 30, 2020; and

WHEREAS, the CDGS awarded the County of Yuba this grant in the amount of \$76,738.85.

WHEREAS, the Director of the Health and Human Services Department seeks to be allocated COVID-19 Emergency Homelessness funds in an amount not to exceed \$76,738.85;

WHEREAS, it is in the interest of efficient and effective county government to have a Resolution of the Board of Supervisors authorizing the HHSD Director to accept the COVID-19 Emergency Homelessness funds and to execute all documents required by the COVID-19 Emergency Homelessness Funding Award;

WHEREAS, it is also in the interest of efficient and effective county government, to have a Resolution authorizing the HHSD Director to transfer and allocate any COVID-19 Emergency Homelessness funds received in accordance with the terms of the award.

NOW, THEREFORE, BE IT RESOLVED, the Yuba County Board of Supervisors hereby authorizes the Director of the Health and Human Services Department to accept the award for the COVID-19 Emergency Homelessness funds.

BE IT FURTHER RESOLVED by the Yuba County Board of Supervisors that the Director of the Health and Human Services Department is hereby authorized to: execute, subject to review and approval of County Counsel, all documents as required by the resultant allocation for the stated period; to execute agreements, memorandums of understanding (MOUs) or amendments developed under the COVID-19 Emergency Homelessness Funding Award, including but not limited to amendments for additional or lesser funding; and to accept, transfer and allocate all COVID-19 Emergency Homelessness funds for the period of July 1, 2019 through June 30, 2020. A copy of the executed agreement, MOU or any amendment thereto shall be filed in the office of the Clerk of the Board.


