RESOLUTION NO. 2020-43

WHEREAS, the County of Yuba, on behalf of its Sheriff’s Department, has established Service Agreements with Hard Rock International and Live Nation to provide supplemental law enforcement services at the Hard Rock Hotel & Casino Sacramento at Fire Mountain and the Toyota Amphitheatre; and

WHEREAS, the Service Agreements provide for Hard Rock International and Live Nation to reimburse the Sheriff’s Department for actual costs for providing supplemental law enforcement services pursuant to California Government Code §53069.8(a); and

WHEREAS, Reserve Deputy Sheriffs are compensated at a specified hourly rate for time worked in their normal capacity with the Sheriff’s Department; and

WHEREAS, Yuba County Ordinance Code Section 3.15.020 provides that “Each person appointed and deputized by the Sheriff as a reserve or auxiliary deputy sheriff shall be entitled to receive an agreed upon stipend while on duty for such service”; and

WHEREAS, the agreed upon regular stipend for a Reserve Deputy I is presently calculated at an rate of \$21.89 per hour and the agreed upon stipend for a Reserve Deputy IA is calculated at an rate of \$29.19 per hour; and

WHEREAS, the Board desires to provide an additional stipend to a Reserve Deputy Sheriff I and Reserve Deputy Sheriff IA to create an incentive to provide supplemental law enforcement services; and

WHEREAS, the regular stipend paid to a Reserve Deputy I and IA classification is related to the base hourly rate of pay for a Deputy Sheriff; and

WHEREAS, the Service Agreements with Hard Rock International and Live Nation provide for reimbursement for supplemental law enforcement services performed by Reserve Deputy Sheriffs; and

WHEREAS, California Government Code §25300 provides the Board of Supervisors to prescribe compensation of county employees.

NOW, THEREFORE, BE IT RESOLVED, the Yuba County Board of Supervisors establishes the compensation for Reserve Deputy Sheriff for supplemental law enforcement services provided pursuant to the Service Agreements with Hard Rock International and Live Nation as follows:

- (A) Reserve Deputy Sheriffs I shall receive their regular stipend calculated at a rate of \$21.89 per hour for each hour that they provide supplemental law enforcement services outside of their normal working hours;
- (B) Reserve Deputy Sheriffs I shall receive an additional stipend calculated at a rate of \$26.11 per hour for each hour that they provide supplemental law enforcement services outside of their normal working hours. This additional stipend shall not be considered special compensation for purposes of determining pensionable compensation or compensation earnable under the Public Employee's Retirement Law;
- (C) In the event there is an increase in the hourly rate of the regular stipend for Reserve Deputy Sheriffs I, the hourly rate of the additional stipend shall be reduced in a like amount so as to ensure that the total amount paid to the Reserve Deputy Sheriffs I does not exceed \$48.00 per hour for each hour they provide supplemental law enforcement services outside of their normal working hours;
- (D) Reserve Deputy Sheriffs IA shall receive their regular stipend calculated at a rate of \$29.19 per hour for each hour that they provide supplemental law enforcement services outside of their normal working hours;
- (E) Reserve Deputy Sheriffs IA shall receive an additional stipend calculated at a rate of \$18.81 per hour for each hour that they provide supplemental law enforcement services outside of their normal working hours. This additional stipend shall not be considered special compensation for purposes of determining pensionable compensation or compensation earnable under the Public Employee's Retirement Law;
- (F) In the event there is an increase in the hourly rate of the regular stipend for Reserve Deputy Sheriffs IA, the hourly rate of the additional stipend shall be reduced in a like amount so as to ensure that the total amount paid to the Reserve Deputy Sheriffs IA does not exceed \$48.00 per hour for each hour they provide supplemental law enforcement services outside of their normal working hours.


