WHEREAS, on August 13, 2019, the Board of Supervisors of the County of Yuba adopted Resolution No. 2019-83 formally adopting the Departmental Position Allocation Schedule effective July 1, 2019; and

WHEREAS, the Community Development Services Agency has now identified a need to remove the vacant Deputy Director of Public Works – Construction and reallocate the Assistant Public Works Director class; and

WHEREAS, the Community Development wishes to change the title of Public Works Project Manager to Construction Manager, which is more easily identifiable to obtain greater visibility and interest from qualified applicants; and

WHEREAS, the Sheriff's Department has evaluated its organizational structure and determined the civilian administrative management position of Administrative Services Manager is better suited to oversee the non-law enforcement functions under the Support Services Division; and

WHEREAS, the Board of Supervisors now intends to amend Resolution No. 2019-83 as it relates to the Departmental Position Allocation Schedule to meet the aforementioned needs for certain positions within the Community Development Services Agency and Sheriff's Department.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors that Resolution No. 2019-83 be and hereby is amended as it relates to the position allocations of the following classifications within the Community Development Services Agency: Assistant Public Works Director and Construction Manager.

BE IT FURTHER RESOLVED by the Board of Supervisors that Resolution No. 2019-83 be and hereby is amended as it relates to the position allocations of the following classification within the Sheriff's Department: Administrative Services Manager.

BE IT FURTHER RESOLVED, effective May 1, 2020, the Departmental Position Allocation Schedule is to be amended as follows:


