WHEREAS, in accordance with federal regulation 45 CFR 1355.34(c) and state statute Welfare and Institutions Code (WIC) 10601.2(a), local county child welfare agencies are responsible for implementing a qualitative case review process for child welfare services by child welfare and probation agencies; and

WHEREAS, cases must be reviewed in accordance with state and federal policies and procedures utilizing the federal On-Site Review Instrument (OSRI), which is published by the Children’s Bureau of the Administration for Children and Family; and

WHEREAS, upon completion of each case review, counties conduct a first-level quality assurance process to maintain the integrity of the review; and

WHEREAS, in order to comply with these regulations, Yuba County would like to enter into an agreement with the California Department of Social Services (CDSS) to have CDSS conduct both case review and first-level quality assurance on behalf of the county; and


WHEREAS, counties are provided with an allocation for staffing for case review activities and Yuba County is qualified to enter into an agreement with CDSS for case review activities.

NOW, THEREFORE, BE IT RESOLVED, that the Yuba County Board of Supervisors hereby authorizes the Health and Human Services Department Director to enter into agreement with the CDSS for conducting both case review and first-level quality assurance, for the period of January 1, 2020 through June 30, 2024.


BE IT FURTHER RESOLVED that the Yuba County Board of Supervisors hereby authorizes the Health and Human Services Department Director to execute, on behalf of the County of Yuba and upon review and approval of County Counsel, agreements, amendments, memorandums of understanding and subsequent documents as related to the case review and first-level quality assurance activities. A copy of the fully executed agreement or any amendment thereto shall be filed in the office of the Clerk of the Board, County of Yuba.
