WHEREAS, the County of Yuba Probation Department desires to continue to undertake multiple projects administered through the California Office of Emergency Services (Cal OES), First Five Yuba (First 5), California Partnership to End Domestic Violence (Partnership), Children’s Advocacy Centers of California (Calico) and California Coalition Against Sexual Assault (CalCASA) and funded by each respective agency; and

WHEREAS, Cal OES is awarding, in the form of a grant, emergency response funds intended to support the needs associated with providing safety and services for victims of interpersonal violence during the COVID-19 pandemic; and

WHEREAS, to facilitate the distribution of these funds, Cal OES has contracted with the Partnership, CalCASA, and Calico to serve as regranting agencies; and

WHEREAS, the County Probation Department was successfully awarded \$22,360 in grant funds from Cal OES and the Partnership for the provision of emergency services to victims of domestic violence during the COVID-19 pandemic; and

WHEREAS, the County Probation Department now seeks to allocate the grant funds pursuant to the terms of the grant.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of Yuba hereby authorizes the following:

1. That fund 101-3106 be renamed COVID-19 Domestic Violence (D.V.) Fund; and
2. That the Yuba County Probation Department’s budget adjustment request be approved as to form.

BE IT FURTHER RESOLVED, that the Board of Supervisors of the County of Yuba hereby agrees that any liability arising out of the performance of any Cal OES grant administered through the County Probation Department, including civil court actions for damages, shall be the responsibility of the grant recipient and the authorizing agency.


