WHEREAS, the California Department of Housing and Community Development (the “Department” or “HCD”) has issued a Notice of Funding Availability (“NOFA”) for the Community Development Block Grant Program (“CDBG”), made available from the U.S. Department of Housing and Urban Development (“HUD”). Funding under this NOFA is made available pursuant to the CARES ACT (Public Law No: 116-136) and the Housing and Community Development Act of 1974 (HCDA) as amended and codified at Title 42 United States Code (U.S.C.) § 5301 et. Seq., and Subpart 1 of the Federal CDBG Regulations, found at Title 24 Code of Federal Regulations (CFR) § 570.480 et seq. The requirements of the state administered CDBG program are in California Health and Safety Code (HSC) §§ 50825-50834. Funding is available to CDBG eligible non-entitlement jurisdictions to perform Activities related to COVID-19 response and recovery. The CARES Act provides extra CDBG funds specifically targeted to prevent, prepare for, and respond to coronavirus. ; and

WHEREAS, in response to the June 5, 2020 CDBG Coronavirus Response Round 1 (CDBG-CV1) NOFA the County of Yuba, a political subdivision of the State of California (Applicant), wishes to submit an application to HCD to apply for and receive an allocation of CDBG Program Coronavirus Response funds up to the amount \$228,607.00, as described in APPENDIX D attached hereto and made a part of herein; and if selected, the execution of a standard agreement, any amendments thereto from the 2020 funding year, and any related

documents necessary to participate in the State CDBG Coronavirus Response Round 1 (CDBG-CV1) Program; and

WHEREAS, pursuant to CDBG regulations, the public has been invited to comment on the proposed “CDBG Coronavirus Response Round 1 (CDBG-CV1) NOFA Application” during a noticed public hearing, as well as to submit written comments; and

NOW, THEREFORE, BE IT RESOLVED, the Yuba County Board of Supervisors hereby declare:

Section 1. That the above recitals are all true and correct.

Section 2. That the County of Yuba shall submit to HCD an application to participate in the Community Development Block Grant Program CDBG Coronavirus Response Round 1 (CDBG-CV1) Notice of Funding Availability (NOFA).

Section 3. That if the application for funding is approved, the County agrees to use the CDBG Coronavirus Response Round 1 (CDBG-CV1) funds for eligible activities in the manner presented in the application as approved by HCD and in accordance with program regulations cited above including any and all other instruments necessary or required by HCD for participation in the CDBG-CV1 Program.

Section 4. That the Board of Supervisors delegates to the Director of CDSA the authority, to execute in the name of the County of Yuba, the application, the Standard Agreement, and all other documents required by HCD for participation in the CDBG-CV1 Program, and any amendments thereto that are consistent with the programs regulations and grant application; including the authorization to sign any and all procedural documents, subject to Counsel review.

Section 5. This Resolution shall take effect upon its adoption.






