**RESOLUTION AUTHORIZING YUBA)

AGENCY TO ENTER INTO A)
MEMORANDUM OF UNDERSTANDING)
WITH SACOG FOR REAP FUNDS**

WHEREAS, Assembly Bill 101 established the Local Government Planning Support Grants Program to provide regions and jurisdictions with one-time funding to establish priorities that increase housing planning and accelerate housing production; and

WHEREAS, Under Assembly Bill 101, the Regional Early Action Planning (REAP) funding source was created which is intended to address the unique housing priorities and planning needs of the various Council of Governments (COG) in California. Sacramento Area Council of Governments (SACOG), as the regional COG for Yuba County, received approximately 7 million dollars through REAP to allocate to Cities and Counties in the SACOG Region; and

WHEREAS, SACOG has set aside \$3,823,000 for noncompetitive grants for member jurisdictions and Yuba County is entitled to a Round 1 funding in the amount of \$19,000 which is required to be spent on Housing Element related work and Round 2 funding in the amount of \$65,000 with respective spending guidelines to be announced in early 2021.

WHEREAS, SACOG requires the County of Yuba to enter into a Memorandum of Understanding in order to receive REAP funds.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors resolves as follows:

SECTION 1. The Yuba County Community Development and Services Agency (CDSA) Director is hereby authorized and directed to enter into, execute, and deliver a Memorandum of Understanding with SACOG for REAP Round 1 funds in an amount of \$19,000, and REAP Round 2 funds in an amount of \$65,000, and any and all other documents required or deemed necessary or appropriate to evidence and secure REAP funds.

SECTION 2. The County shall be subject to the terms and conditions as specified in the Memorandum of Understanding, and any applicable REAP guidelines published by SACOG.

Funds are to be used for allowable expenditures as specifically identified in the Memorandum of Understanding. Any and all activities funded, information provided, and timelines represented in the REAP funding will be enforceable through the executed Memorandum of Understanding. Yuba County CDSA hereby agrees to use the funds for eligible uses in the manner presented in the application as approved by SACOG.
