**RESOLUTION ADOPTING ORDER OF)
VACATION OF THE NORTH-SOUTH)
PORTION OF LINCOLN AVENUE)**

RESOLUTION NO. 2020-108

WHEREAS, the vacation which is the subject of this resolution is made pursuant to the California Streets and Highways Code commencing at section 8320; and

WHEREAS, Lincoln Avenue (County Road #250) is listed on the maintained mileage list of Yuba County, having a maintained length of 0.81 miles.

WHEREAS, a request has been presented by James M. Ratliff, a local citizen having interest in land accessed using Lincoln Avenue, to abandon the portion of Lincoln Avenue that runs north-south as described in Exhibit "A", attached hereto and made a part hereof; and

WHEREAS, that portion of Lincoln Avenue described in the attached "Exhibit A" is used for access to farmland owned by two families, both of which want the road to be vacated; and

WHEREAS, public services easements are being reserved to provide for the existing public utility facilities along that portion of Lincoln Avenue, as described in Exhibit "A"; and

NOW, THEREFORE, the Board of Supervisors hereby finds, declares and orders:

1. Pursuant to and in accordance with the procedures contained in the aforesaid Streets and Highways Code commencing at section 8320, notice was duly published in the Appeal Democrat, a newspaper of general circulation published in Yuba County,

- for two successive weeks prior to the date fixed for hearing, with publication dates being August 8, 2020 and August 15, 2020, and notice of said public hearing was conspicuously posted on August 7, 2020, along the lines of said road proposed to be vacated, with the posted notice to remain along the road until after the hearing.
2. A public hearing was held as published by the Board of Supervisors to hear any protests or objections to the intention to vacate said road on August 25, 2020.
 3. At said public hearing all persons present were given an opportunity to hear and be heard with respect to any matter relative to this proposed vacation.
 4. After hearing the evidence offered by the interested persons, the Board of Supervisors finds that the right of way is unnecessary for present or prospective public use.
 5. That from and after the date this resolution is recorded, the right of way is hereby generally vacated and shall no longer constitute a street or highway.
 6. That the following is reserved from this vacation;
 - a) a Public Utility Easement and right at any time, or from time to time, to construct, maintain, operate, replace, remove, and renew sanitary sewers, water lines and storm drains and appurtenant structures in, upon, over, and across said strip of land and, pursuant to any existing franchise or renewals thereof, or otherwise, to construct, maintain, operate, replace, remove, renew, and enlarge lines of pipe, conduits, cables, wires, poles, and other convenient structures, equipment, and fixtures for the operation of gas pipelines, telegraphic and telephone lines, and for the transportation or distribution of electric energy, petroleum and its products, and for incidental purposes, including access to protect these works from all hazards in, upon, and over the street being vacated.
 - b) a private easement for ingress and egress for the benefit of those parcels currently using Lincoln Avenue for access from Kibbe Road.

7. The Clerk of the Board of Supervisors shall cause a certified copy of this resolution to be recorded in the office of the County Recorder, County of Yuba.



Road Abandonment
Portion of Lincoln Avenue

All that portion of Lincoln Avenue (County Road #250) that runs north and south, which begins approximately 1300 feet east of the intersection of Lincoln Avenue and Kibbe Road. Said road lies within the west half of Section 24, in Township 16 North, Range 4 East, Mount Diablo Base and Meridian.

NOTICE OF HEARING OF RESOLUTION DECLARING INTENTION TO VACATE THE PORTION OF LINCOLN AVENUE (COUNTY ROAD #250) THAT RUNS NORTH AND SOUTH, WHICH BEGINS APPROXIMATELY 1300 FEET EAST OF THE INTERSECTION OF LINCOLN AVENUE AND KIBBE ROAD. SAID ROAD LIES WITHIN THE WEST HALF OF SECTION 24, IN TOWNSHIP 16 NORTH, RANGE 4 EAST, MOUNT DIABLO BASE AND MERIDIAN, AS SHOWN ON YUBA COUNTY ASSESSOR'S MAP BOOK 5, PAGE 10.

NOTICE IS HEREBY GIVEN, pursuant to the California Streets and Highways Code commencing at section 8320, that on Tuesday, August 25, 2020 at the hour of 9:00 a.m. on said day, via a Board of Supervisors Zoom teleconference call, is hereby fixed as the time and place for hearing of the resolution of the Board of Supervisors of the County of Yuba for the vacation of the portion of Lincoln Avenue (County Road #250) that runs north and south, which begins approximately 1300 feet east of the intersection of Lincoln Avenue and Kibbe Road.
