**WHEREAS**, the California Department of Public Health (CDPH) has made grant funds available for the purpose of sexually transmitted disease (STD) prevention and control programs through the STD Program Management and Collaboration Project; and

**WHEREAS**, the CDPH has authority to grant funds for the STD Program Management and Collaboration Project under Health and Safety Code 131085(a); and

**WHEREAS**, the CDPH has allocated \$764,245.00 in grant funds to the County of Yuba ("County") for fiscal years 2019-2024; and

**WHEREAS**, it is in the best interest of the residents of the County of Yuba to participate in the STD Program and utilize the funds to enhance services to persons within the community with the goal of improving the health and wellbeing for all residents; and

**WHEREAS**, the Director of the HHSD seeks to apply for and be allocated STD program funds in an amount not to exceed \$764,245.00; and

**WHEREAS**, it is in the interest of efficient and effective county government to have a Resolution of the Board of Supervisors authorizing the HHSD Director to apply for the STD Program and to execute all documents required by the STD Program application;

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Supervisors of the County of Yuba that the HHSD Director is hereby authorized to accept the aforementioned allocation for the Public Health Division for the term of Fiscal Years 2019-2024, and any subsequent funds allocated for the stated period; and

**BE IT FURTHER RESOLVED**, that the HHSD Director is authorized to execute, upon review and approval of the County Counsel, any and all documents as required by the STD Program for the stated period; and

**BE IT FURTHER RESOLVED**, the HHSD Director is authorized to execute the transfer and allocate funds for the stated period in accordance with the STD Program; and


