RESOLUTION NO. 2021-017

WHEREAS, the California Department of Social Services (CDSS) has made emergency funds available to implement or expand non-congregate shelters for homeless person and assist participants in their transition to permanent housing; and

WHEREAS, on November 16, 2020 Governor Newsom announced emergency funding from the State’s Disaster Response Emergency Operations Account to allow the Project Roomkey operations to continue; and

WHEREAS, the goal of these funds is to ensure the safety of participants during the ongoing public health emergency and to increase the rate and speed of rehousing placements out of PRK sites; and

WHEREAS, counties must submit an application and request a funding allocation, which may be in an amount greater than or less than the county’s need, as determined and allocated by the CDSS; and

WHEREAS, the goal is to continue to keep people experiencing homelessness and their communities safe during the COVID-19 pandemic; and

WHEREAS, the CDSS has allocated \$20,00.00 to the County of Yuba (County) for fiscal years 2020-2021 to continue these operations; and

WHEREAS, the County Director of the Health and Human Services Department (Director) seeks to apply for and be allocated Project Roomkey funds; and

WHEREAS, the Director shall, at the earliest possible date, obtain approval of the Project Roomkey and Rehousing Strategy program from the Board of Supervisors at a regular meeting of the Board of Supervisors.

NOW, THEREFORE, BE IT RESOLVED, the Yuba County Board of Supervisors hereby authorizes the Director of the Health and Human Services Department to submit an application for this allocation.

BE IT FURTHER RESOLVED by the Yuba County Board of Supervisors that the Director of the Health and Human Services Department is hereby authorized to: execute, subject to review and approval of County Counsel, all documents as required by the application and the resultant allocation for the stated period; to execute agreements, memorandums of understanding (MOUs) or amendments developed under Project Roomkey, including but not limited to amendments for additional or lesser funding; and to accept, transfer and allocate all funds by June 30, 2021. A copy of the executed agreement, MOU or any amendment thereto shall be filed in the office of the Clerk of the Board.


