WHEREAS, on August 25, 2020, the Board of Supervisors of the County of Yuba adopted Resolution number 2020-101 formally adopting the Classification System – Basic Salary / Hourly Schedule effective August 1, 2020; and

WHEREAS, the Assistant County Administrator class is allocated to the County Administrator’s Office but has been unfunded since December of 2010; and

WHEREAS, the newly appointed County Administrator intends to fund the Assistant County Administrator allocation to hire a qualified candidate; and

WHEREAS, the Human Resources Department conducted a salary review of the Assistant County Administrator class seeks to adjust the base salary in a manner consistent with external and internal comparable data; and

WHEREAS, the County Administrator requests hiring authority from the Board of Supervisors to appoint an Assistant County Administrator up to the 1.30 index rate; and

WHEREAS, the Board of Supervisors now intends to amend Resolution No. 2020-101 as it relates to the Classification System – Basic Salary/Hourly Schedule to adjust salary data for the Assistant County Administrator classification, effective February 1, 2021.

NOW THEREFORE, BE IT RESOLVED, by the Board of Supervisors of the County of Yuba, that Resolution number 2020-101 be and hereby is amended as it relates to the Assistant County Administrator classification.

BE IT FURTHER RESOLVED, by the Board of Supervisors of the County of Yuba, that the County Administrator is granted the authority to hire an Assistant County Administrator up to the 1.30 index rate; and

BE IT FURTHER RESOLVED, the Classification System – Basic Salary / Hourly Schedule as documented in Attachment A, attached hereto and incorporated herein by reference as though fully set forth, is hereby established and effective February 1, 2021.


