RESOLUTION NO. 2021-060

WHEREAS, the Governor of the State of California in cooperation with the California State Legislature has enacted the State of California Climate Investment, which provides funds to the State of California and its political subdivisions for fire prevention programs; and

WHEREAS, the State Department of Forestry and Fire Protection (CAL FIRE) has been delegated the responsibility for the administration of the program within the State, setting up necessary procedures governing applications by local agencies, non-profit organizations, and others under the program; and

WHEREAS, the County will enter into an agreement with the State of California to carry out the Yuba County – *FOOTHILLS FUEL REDUCTION PROJECT*.

NOW, THEREFORE, BE IT RESOLVED that the Yuba County Board of Supervisors authorizes the submittal of an application under the “California Climate Investment Fire Prevention Grant Program”; and

BE IT FURTHER RESOLVED that the County has or will have sufficient funds to operate and maintain the project; and

BE IT FURTHER RESOLVED that funds under the jurisdiction of the Yuba County Board of Supervisors are available to begin the project; and

BE IT FURTHER RESOLVED that the County will expend grant funds prior to March 15, 2025; and

BE IT FURTHER RESOLVED that the Public Works Director, or his/her designee, is hereby authorized and empowered to execute in the name of the County of Yuba all grant documents, including but not limited to, applications, agreements, amendments and requests for

payment, and commit local share funds (Road Fund) as necessary to secure grant funds and implement the Yuba County – *FOOTHILLS FUEL REDUCTION PROJECT*; and

BE IT FURTHER RESOLVED that these authorizations are effective for ten (10) years from the date of adoption of this resolution.


