WHEREAS, the Coronavirus Response and Relief Supplemental Appropriations (CRRSA) Act was signed into law by the President of The United States on December 27, 2020; and

WHEREAS, the Federal Aviation Administration (FAA) is administering the award and distribution of \$2 billion in CRRSA Act funds to U.S. airports; and

WHEREAS, the CRRSA Act Grant funds have no local match requirements. All funds under the CRRSA Act are available at a 100% Federal share; and

WHEREAS, CRRSA Act grant funds can be used for any purpose for which airport revenues may be lawfully used.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Supervisors of the County of Yuba hereby makes the following determinations:

1. The Yuba County Director of Administrative Services is hereby authorized to complete and submit an application for the CRRSA Act grant to the Federal Aviation Administration, on behalf of Yuba County.
2. The Yuba County Director of Administrative Services is hereby authorized to execute all related grant documents including, but not limited to; applications, agreements, amendments, closeout documents, and requests for payment.

3. The Yuba County Director of Administrative Services is hereby authorized to accept the resultant grant award from the Federal Aviation Administration, on behalf of the County of Yuba, and to execute any related documents.
4. The Yuba County Director of Administrative Services is hereby authorized to allocate and disburse said grant funds in support of the Airport operations and improvements.

NOW, THEREFORE, BE IT FURTHER RESOLVED, that the Board of Supervisors of the County of Yuba hereby authorizes Administrative Services Director to execute any and all necessary documents relating to CRRSA Act Grant, subject to approval by County Counsel.
