WHEREAS, the California Department of Social Services (“CDSS”) has made funds available to implement or continue an existing California Work Opportunity and Responsibility to Kids (“CalWORKs”) Housing Support Program (HSP) through Fiscal Year (“FY”) 2021-2022; and

WHEREAS, established by Senate Bill 855 (Chapter 29, Statutes of 2014), the objective of the CalWORKs HSP is to foster housing stability for families experiencing homelessness in the CalWORKs program; and

WHEREAS, counties must submit an application and request funds in an amount sufficient to meet their need, while considering their capacity to utilize the funds; and

WHEREAS, counties seeking to continue operating an existing CalWORKs HSP will receive a planning allocation equal to their FY 2020-2021 base allocation plus funding based on the county’s program performance in FY 2019-2020. Funds requested in excess of the planning allocation will be allocated on a competitive basis in accordance with established criteria. Final FY 2021-2022 allocations will be announced by the CDSS by fall 2021; and

WHEREAS, Yuba County has been allocated a base allocation of \$1,358,162 plus a performance allocation of \$101,862.15 – a 7.5% increase over their base allocation due to their strong performance in FY 2019-2020 – for a total planning allocation of \$1,460,024.15 for FY 2021-2022; and

WHEREAS, the HHSD Director seeks to apply for and be allocated CalWORKs HSP funds in an amount not to exceed \$2,000,000 – consisting of \$1,460,024.15 from the planning allocation plus competitive funding that will be requested in excess of the planning allocation; and

WHEREAS, it is in the best interest of the residents of Yuba County for HHSD to participate in the CalWORKs HSP and utilize the funds to address families' immediate housing crisis, alleviate their homelessness and focus on providing wrap-around services to the families in order to stabilize and support them in achieving permanent housing and self-sufficiency.

NOW, THEREFORE, BE IT RESOLVED by the Yuba County Board of Supervisors that the HHSD Director is authorized to submit an application for the CalWORKs HSP.

BE IT FURTHER RESOLVED by the Yuba County Board of Supervisors that the HHSD Director is hereby authorized to: execute, subject to review and approval of County Counsel, all documents as required by the application and the resultant allocation for the period of July 1, 2021 through June 30, 2022; execute agreements, memorandums of understanding (MOUs) or amendments developed under the CalWORKs HSP, including but not limited to amendments for additional or lesser funding; and accept, transfer and allocate all CalWORKs HSP funds and any subsequent funds awarded for the stated period.

A copy of the said agreements, MOUs or any amendments thereto shall be filed in the office of the Clerk of the Board, County of Yuba.


