WHEREAS, Yuba County applied for the Coronavirus Emergency Supplemental Funding (CESF) Program through the Board of State and Community Corrections (BSCC) for emergency relief funds due to the Coronavirus health pandemic; and

WHEREAS, The Coronavirus Emergency Supplemental Funding (CESF) Program Grant amount to Yuba County is approximately \$102,000.00 and 20% of the grant funds will be used for a pass through to a non-profit organization; and

WHEREAS, Allowable projects and purchases, as determined by the BSCC, include but are not limited to addressing the medical needs of inmates and detainees, procurement of personal protective equipment for medical or law enforcement personnel, reimbursement for first responder overtime or hiring, training or travel, as well as additional supplies necessary to keep operation areas sanitized; and

WHEREAS, Yuba County will utilize the funds to procure and install ionization systems in the existing air handler units at the Yuba County Jail and the Juvenile Detention Facility, which will reduce the risk of airborne viruses and allow for purified airflow throughout the facilities; and

WHEREAS, Yuba County has applied for and has been approved for the grant; this resolution ratifies applying for the grant, executing the agreement and all other documents, receiving and dispersing funds, preparing for the project, construction of the project, administering the grant program, and project closeout; and

NOW, THEREFORE, BE IT RESOLVED, that the Board of Supervisors of the County of Yuba hereby authorizes the County Administrator to apply for, execute, and accept grant funding from the BSCC, to procure and install the ionization systems in the Yuba County Jail and Juvenile Detention Facility, and administer the pass through funds, subject to approval of County Counsel.


