**RESOLUTION NO. 2021-084**

**WHEREAS**, Public Works is currently administering a paving contract for the work on County Service Area (CSA) 72 road, Candlewood Way; and

**WHEREAS**, on April 27, 2021 a public hearing and Proposition 218 vote was passed for an increase in assessments to fund the paving of Candlewood. Completing this paving project was contingent upon the pledge of the residents of CSA 72 to donate \$30,000 towards the paving costs; and

**WHEREAS**, there are currently not enough funds in the CSA 72 to coverage the cost, but there will be in three years based on the new assessment rate; and

**WHEREAS**, the Board of Supervisors are empowered by the California Government Code to borrow money for and make loans to a CSA; and

**WHEREAS**, CSA 66 has adequate funds in trust to allow for the borrowing without adversely affecting current services and future projects for CSA 66; and

**WHEREAS**, it is in the best interest of the County and CSA 72 residents to borrow \$80,500 from CSA 66, to be repaid by future CSA 72 assessment revenues. This amount along with the donations of \$30,000 from CSA 72 residents will cover the paving costs.

**NOW, THEREFORE, BE IT RESOLVED**, the Yuba County Board of Supervisors hereby authorizes the borrowing of up to \$80,500 from the CSA 66 Trust Fund to the CSA 72 Trust Fund for the paving of Candlewood Way, to be repaid with interest at the county pool rate, from future CSA 72 assessment revenues in accordance with the Board's powers under Government Code §25214.4 (a). The Board also accepts the donation of \$30,000 from the CSA 72 resident with the fund to used only for the paving of Candlewood Way.
