**WHEREAS**, the Board of Supervisors now intends to amend the Classification System – Basic Salary/Hourly Schedule as it relates to contractual agreements and as it relates to the following classifications: Deputy County Counsel I, Deputy County Counsel II, and Deputy County Counsel III; and


