**WHEREAS**, on July 13, 2021 the Board of Supervisors approved Resolution No. 2021-097 regarding the Extra Help Classification System - Hourly Schedule (Attachment "C) as it relates to the contractual agreements between the County of Yuba and the Yuba County Deputy Sheriff's Association and application of benefits to Reserve Deputy Sheriff Level I / IA / II effective July 1, 2021; and

**WHEREAS**, the Reserve Deputy Sheriff Level IA hourly rate was transposed which impacted the formula that determines the hourly rate for the Reserve Deputy Sheriff Level I and Level II; and

**WHEREAS**, Human Resources seeks to amend the Extra Help Classification System – Hourly Schedule to correct the hourly rate for the following Extra Help classifications: Reserve Deputy Sheriff Level IA / I / II effective July 1, 2021; and

**WHEREAS**, the Board of Supervisors now intends to amend Resolution No. 2021-097 as it relates to the Extra Help Classification System - Hourly Schedule as it relates to Reserve Deputy Sheriff Level I / IA / II; and


