**WHEREAS**, Article XIII B of the California Constitution establishes a limitation on spending by government entities from proceeds of taxes; and

**WHEREAS**, in accordance with Government Code Section 7910, the Board of Supervisors of the County of Yuba must establish an annual appropriations limit; and

**WHEREAS**, the Board of Supervisors of the County of Yuba has complied with the provisions of Article XIII B in determining the appropriations limit for fiscal year 2021-22; and

**WHEREAS**, in accordance with Government Code Section 7910, the information on the calculation of the appropriations limit has been made available to the public at least 15 days prior to the date of adoption of this resolution, and continues to be available for public inspection.

**NOW THEREFORE, BE IT RESOLVED**, in accordance with Article XIII B of the California Constitution and Government Code Section 7900 et seq., the adjustment factors to be applied to the appropriations limit for the 2020-2021 fiscal year shall be the Change in New Construction adjustment factor and the Yuba County population adjustment factor.

**BE IT FURTHER RESOLVED**, in accordance with Article XIII B of the California Constitution and Government Code Section 7902, the appropriations limit for fiscal year 2021-22 is hereby established as \$90,443,411, as documented in Exhibit A, attached hereto and incorporated herein by reference as though fully set forth, but that such appropriations limit may be adjusted at a later date in accordance with Sections 3 and 11 of Article XIII B.


