WHEREAS, on July 13, 2021, the Board of Supervisors of the County of Yuba adopted Resolution number 2021-097 formally adopting the Classification System – Basic Salary/Hourly Schedule in its entirety effective July 1, 2021.

WHEREAS, on November 10, 2020, the Board of Supervisors approved the employment agreement with the Community Development Services Agency Director, effective November 1, 2020; and

WHEREAS, said employment agreement includes the clause for the Board of Supervisors to modify the class specification as determined necessary; and

WHEREAS, the Board of Supervisors has directed a revision to the Community Development Services Agency Director class specification to include the responsibility to serve as the County's Building Official pursuant to Health & Safety Code §18949.27 et seq., and the County Surveyor pursuant to Government Code §27550; and

WHEREAS, the Board of Supervisors has further directed an adjustment to the base salary for Community Development Services Agency Director as a result of the class specification revision and additional duties and responsibilities; and

WHEREAS, the Board of Supervisors recognizes the base salary adjustment to the Community Development Services Agency Director class is outside the customary practice within the County's compensation system; and

WHEREAS, the Board of Supervisors now intends to amend the Classification System – Basic Salary/Hourly Schedule as it relates Community Development Services Agency Director class; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors, the Classification System – Basic Salary/Hourly Schedule is hereby amended as it relates to Community Development Services Agency Director class.

BE IT FURTHER RESOLVED, the Classification System – Basic Salary/Hourly Schedule as documented in Attachment “A” and attached hereto and incorporated herein by reference as though fully set forth, is hereby established and effective September 1, 2021.


