WHEREAS, the State of California – Office of Traffic Safety has made grant funds available to provide pedestrian and bicycle safety related activities to reduce the number of persons killed and injured in accidents involving pedestrians and bicyclists; and

WHEREAS, it is in the best interest of the residents of the County of Yuba to receive pedestrian and bicycle safety education classes, conduct bicycle helmet inspections, distribute safety equipment, and other related resources provided through the Health and Human Services Department, Public Health Division, as a result of receiving and utilizing these funds; and

WHEREAS, Yuba County Health and Human Services Department (HHSD), through its Public Health Division, has been awarded grant funds in the amount of \$57,700.00 for the period of October 1, 2021 through September 30, 2022.

NOW, THEREFORE, BE IT RESOLVED by the Yuba County Board of Supervisors that the HHSD Director is hereby authorized to: enter into agreement with the State of California – Office of Traffic Safety for the Pedestrian and Bicycle Safety Program grant for the period of October 1, 2021 through September 30, 2022; execute, subject to review and approval of County Counsel, all documents as required by the grant for the stated period; accept, transfer and allocate the grant funds and any

subsequent funds awarded for the stated period; amend the agreement for additional or lesser funding; and execute agreements, memorandums of understanding (MOUs) or amendments developed under the program. A copy of the fully executed agreement, MOU or any amendment thereto shall be filed in the office of the Clerk of the Board, County of Yuba.
