WHEREAS, on July 13, 2021, the Board of Supervisors of the County of Yuba adopted Resolution number 2021-097 formally adopting the Classification System – Basic Salary / Hourly Schedule effective July 1, 2021; and

WHEREAS, the Media and Community Relations Specialist class was established on November 12, 2019, for the County Administrator's Office to assist in managing the County's social media relations and internal and external communications in real time; and

WHEREAS, the Media and Community Relations Specialist class was exclusively assigned to the confidential unit in the County Administrator's Office as an incumbent would likely have regular access to confidential information related to collective bargaining; and

WHEREAS, the Health and Human Services Department has need of its own Media and Community Relations Specialist to be dedicated to work on branding and messaging for the Department and to build community trust through various communication, outreach, and education outlets; and

WHEREAS, the Health and Human Services Department is unable to allocate a Media and Community Relations Specialist while it is exclusively assigned to the confidential unit as its purpose would be outside the definition of a confidential employee as defined by the National Labor Relations Board; and

WHEREAS, the Human Resources Department seeks to establish a Media and Community Relations Specialist class assigned to the professional unit to allow the Health and Human Services Department the ability to utilize this class for business purposes; and

WHEREAS, the Board of Supervisors now intends to amend Resolution No. 2021-097 as it relates to the Classification System – Basic Salary/Hourly Schedule to add the class of Media and Community Relations Specialist assigned to the professional unit with a same base salary as the Media and Community Relations Specialist class assigned to the confidential unit, effective October 1, 2021.

NOW THEREFORE, BE IT RESOLVED, by the Board of Supervisors of the County of Yuba, that Resolution number 2021-097 be and hereby is amended as it relates to the Media and Community Relations Specialist classification.

BE IT FURTHER RESOLVED, the Classification System – Basic Salary / Hourly Schedule as documented in Attachment A, attached hereto and incorporated herein by reference as though fully set forth, is hereby established and effective October 1, 2021.
