RESOLUTION NO. 2021-160

WHEREAS, the California Department of Social Services ("CDSS") has made funds available to establish, continue, and expand housing and homelessness assistance through the Housing and Disability Income Advocacy Program ("HDAP"); and

WHEREAS, the HDAP is a locally administered program operated by counties, tribes, or groups of counties and tribes, that provide housing supports and disability benefit application assistance and advocacy to people likely eligible for disability benefits and experiencing homelessness or at risk of homelessness; and

WHEREAS, the Budget Act of 2021 (Senate Bill 129, Chapter 69, Statutes of 2021) appropriated a total of \$175 million for HDAP in Fiscal Year ("FY") 2021-22 with \$25 million to be expended through June 30, 2022 and the remainder to be expended through June 30, 2024; and

WHEREAS, the CDSS has Noncompetitive Allocation funding available for all fifty-eight (58) counties and two (2) continuing tribes in an amount based on a local need methodology established by CDSS. Counties and two (2) continuing tribes must sign and submit a Director's Certification to accept these funds, which do not have a match requirement and must be expended by June 30, 2024; and

WHEREAS, the CDSS has Targeted Strategic Investment funding available for all counties and tribes that will be awarded on a first come, first served basis. Counties and tribes must submit an Application to receive these funds, which requires a dollar-for-dollar match and must be expended by June 30, 2022; and

WHEREAS, Noncompetitive Allocation funding not accepted by way of a completed Director's Certification, including funds declined by a county or continuing tribe will be made available to grantees seeking Targeted Strategic Investment funding or through a subsequent allocation. Additionally, if all Targeted Strategic Investment funding available is not applied for, the CDSS will notify counties and tribes of additional funds available; and

WHEREAS, the CDSS has allocated \$292,042 of HDAP FY 2021-22 Noncompetitive Allocation funding to Yuba County; and

WHEREAS, the HHSD Director seeks to submit a Director's Certification to accept Yuba County's HDAP FY 2021-22 Noncompetitive Allocation funding; and

WHEREAS, the HHSD Director also seeks to submit an Application to apply for and be awarded HDAP Targeted Strategic Investment funding.

NOW, THEREFORE, BE IT RESOLVED by the Yuba County Board of Supervisors that the HHSD Director is authorized to submit a Director's Certification for Yuba County's HDAP FY 2021-22 Noncompetitive Allocation funding and any subsequent funds allocated.

BE IT FURTHER RESOLVED by the Yuba County Board of Supervisors that the HHSD Director is authorized to submit an Application for HDAP Targeted Strategic Investment funding and any subsequent funds made available.

BE IT FURTHER RESOLVED by the Yuba County Board of Supervisors that the HHSD Director is authorized to: execute, subject to review and approval of County Counsel, all documents as required by the Certifications/Applications and the resultant allocations/awards for the term of July 1, 2021 through June 30, 2024 including subsequently extended term; execute agreements, memorandums of understanding (MOUs) or amendments developed under HDAP, including but not limited to amendments for additional or lesser funding; and accept, transfer and allocate all HDAP funds and any subsequent funds allocated/awarded for the stated period.

A copy of the executed agreement, MOU or any amendment thereto shall be filed in the office of the Clerk of the Board.
