WHEREAS, the Yuba County Sheriff’s Department became a State Office of Emergency Services (“OES”) Mutual Aid resource and can be called upon to respond statewide as needed; and

WHEREAS, both the State and Yuba County Sheriff’s Department desire to continue this mutual aid relationship; and

WHEREAS, the State Department of Boating and Waterways offers grants for replacement of such equipment and the Sheriff’s Department has applied for and has been awarded a grant for the purchase of updated dive gear.

Sheriff Wendell Anderson is hereby authorized to execute, on behalf of the County of Yuba, that certain State Department of Parks and Recreation, Division of Boating and Waterways Grant Agreement Number C21L0620 in the form of copies thereof on file with the Clerk of the Board of Supervisors of the County of Yuba.
2. Sheriff Wendell Anderson is hereby authorized to procure said dive equipment according to the procurement standards outlined in Article 12 of the Grant Agreement and to execute written payment request for the disbursement of grant funds according to Article 3 of the grant agreement.


