RESOLUTION NO. 2021-163

WHEREAS, the California Department of Social Services ("CDSS") has made funds available to establish, continue, and expand housing and homelessness assistance through the Home Safe Program; and

WHEREAS, the Home Safe is a locally administered program that supports the safety and housing stability of seniors and adults with disabilities served by or in the intake process for Adult Protective Services who are experiencing homelessness or at risk of homelessness; and

WHEREAS, the Budget Act of 2021 (Senate Bill 129, Chapter 69, Statutes of 2021) appropriated a total of \$92.5 million for Home Safe in Fiscal Year ("FY") 2021-22 to be expended through June 30, 2024; and

WHEREAS, the CDSS has Noncompetitive Allocation funding available for all fifty-eight (58) counties in an amount based on a local need methodology established by CDSS. Counties must sign and submit a Director's Certification to accept these funds, which do not have a match requirement and must be expended by June 30, 2024; and

WHEREAS, Noncompetitive Allocation funding not accepted by way of a completed Director's Certification, including funds declined by a county will be allocated to counties that indicate they can accept additional funds, as indicated in the Director's Certification; and

WHEREAS, the CDSS has allocated \$287,592 of Home Safe FY 2021-22 Noncompetitive Allocation funding to Yuba County; and

WHEREAS, the HHSD Director seeks to submit a Director's Certification to accept Yuba County's Home Safe FY 2021-22 Noncompetitive Allocation funding.

NOW, THEREFORE, BE IT RESOLVED by the Yuba County Board of Supervisors that the HHSD Director is authorized to submit a Director's Certification for Yuba County's Home Safe FY 2021-22 Noncompetitive Allocation funding and any subsequent funds allocated.

BE IT FURTHER RESOLVED by the Yuba County Board of Supervisors that the HHSD Director is authorized to: execute, subject to review and approval of County Counsel, all documents as required by the Certifications and the resultant allocations for the term of July 1, 2021 through June 30, 2024 including subsequently extended term; execute agreements, memorandums of understanding (MOUs) or amendments developed under Home Safe, including but not limited to amendments for additional or lesser funding; and accept, transfer and allocate all Home Safe funds and any subsequent funds allocated for the stated period.

A copy of the executed agreement, MOU or any amendment thereto shall be filed in the office of the Clerk of the Board.


