RESOLUTION NO. 2021-170

WHEREAS, the U.S. Department of Housing and Urban Development (HUD) makes funding available through annual grants to cities and counties to support low- and moderate-income persons and communities; and

WHEREAS, the Community Development Block Grant (CDBG) program is administered through the California Department of Housing and Community Development (HCD) pursuant to specific program eligibility criteria; and

WHEREAS, The County applied and was approved for several projects within the last few funding years of the State CDBG program; and

WHEREAS, it has become necessary to secure a funding source to cover eligible program expenditures up front and then apply for state reimbursement to solve a cash flow issue; and

WHEREAS, staff has identified a maximum of \$2,667,075.00 that will be needed for advance funding for the full terms of select CDBG projects identified in Attachment A of the Staff Report; and

WHEREAS, Fund 299 Building Trust was identified as the most viable funding source to satisfy the immediate need of the identified projects; and

WHEREAS, these funds are not supplanting CDBG, CDBG-MIT, or CDBG-DR funds and the Fund 299 Building Trust funds are earmarked for Building Department expenditures, construction permit services and departmental cost of operations; and

WHEREAS, staff has evaluated the sources and determined that there is no Duplication of Benefits between the funds, nor will the advance funding create a Duplication of Benefits within each program.

WHEREAS, all funds advanced to the program will be repaid immediately upon receipt of the CDBG grant funding reimbursement.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Supervisors of the County of Yuba, based on the foregoing findings, does hereby determine that it is in the best interest of the Community Development Block Grant (CDBG) program and the County to assist in facilitating current projects by advancing funds from County Fund 299 to pay upfront costs associated with such projects. Repayment of the advanced funds will occur as CDBG reimbursement payments are received.

BE IT FURTHER RESOLVED that the Board of Supervisors authorizes the Yuba County Community Development and Services Agency Director, or his designee, to execute any necessary documents related to the advanced funding up to the maximum of \$2,667,075.00. Any funding in excess of the stated amount will require additional review by Counsel and Board Approval.




