WHEREAS, The California Fire Safe Council (“CFSC”), in partnership with California State Association of Counties and Rural County Representatives of California, has dedicated funds for California counties with lands located within the State Responsibility Area for fire protection; and

WHEREAS, the CFSC 2021 CALFIRE County Coordinators Grant (“Grant”) intends to assist counties in the coordination of analyzing gaps in countywide wildfire resiliency and emergency preparedness, building a census of wildfire mitigation groups, contacts and projects, and improving outreach, planning and coordination; and

WHEREAS, the County of Yuba, through Community Development and Services Agency, has submitted an application to the CSFC for the maximum grant amount of \$175,000.00; and

WHEREAS, the County of Yuba acknowledges compliance with the requirements for participation in the Grant; and

WHEREAS, the application submitted to the CSFC has been approved, the Director of Community Development and Services Agency, or his designee, requests authorization to execute any related documents that may be required from time-to-time, and to act on the County’s behalf in all matters pertaining to such applications and related documents.

NOW, THEREFORE, BE IT RESOLVED, the Board of Supervisors of Yuba County does hereby declare the following:


