WHEREAS, in 2019, a needs assessment and strategic plan were performed at the Yuba County Library, identifying areas of opportunity and needed critical maintenance infrastructure improvements that would enhance collections, programs, technology and overall library safety/operations; and

WHEREAS, the California State Library opened a competitive grant opportunity through the Building Forward Library Infrastructure Program which provides for up to \$10 million in one-time funds per library to support local library maintenance, capital projects, broadband, technology upgrades, and purchasing of devices; and

WHEREAS, Yuba County staff submitted a preliminary application questionnaire, which is designed to help the California State Library identify the types of projects that cities, counties, and districts intend to apply for, identifying needed critical maintenance and life-safety infrastructure improvements at the Yuba County Library; and

WHEREAS, grant funding will support improvements to paths of travel, lighting, energy efficiency, accessibility, modernization, reorganization, broadband and technology, to promote the mission of the Yuba County Library to teach and nurture the love of reading and the habit of life-long learning; and

WHEREAS, it is the intent of County staff to apply for grant funding to address certain critical maintenance and life-safety infrastructure improvements.

NOW, THEREFORE, BE IT RESOLVED that the Yuba County Board of Supervisors hereby authorizes the Community Development Services Agency Director and/or Administrative Services Director to apply for, execute, and accept grant funding from the California State

Library to address the critical maintenance and life safety improvements at the Yuba County Library.

BE IT FURTHER RESOLVED, that the Yuba County Board of Supervisors authorizes the Community Development Services Agency Director and/or Administrative Services Director to execute all documents necessary to administer said grant to successful completion of the improvements, subject to approval by County Counsel.


