RESOLUTION NO. 2022-02

WHEREAS, the California Department of Housing and Community Development (“CDHCD”) has allocated funding of the Transitional Housing Program (“THP”) to counties for the purpose of housing stability to help young adults aged 18 to 24 years secure and maintain housing, with priority given to young adults formerly in the foster care or probation systems; and

WHEREAS, in agreement with the California Department of Social Services, the California Department of Finance, and the County Welfare Directors Association, the THP Round 3 allocations have been determined for counties that have a demonstrated need to provide housing for young adults aged 18 to 24 years; and

WHEREAS, the CDHCD has allocated \$13,600 of THP Round 3 funding to Yuba County; and

WHEREAS, to accept and receive the funding for Round 3, counties must submit the required application documents pertaining to the THP allocation; and

WHEREAS, if funds remain available after the application deadline, the CDHCD may advise counties of an additional allocation from these remaining funds; and

WHEREAS, the HHSD Director seeks to submit the required application documents to accept Yuba County’s THP Round 3 allocation in the amount of \$13,600 and any subsequent funds allocated.

NOW, THEREFORE, BE IT RESOLVED by the Yuba County Board of Supervisors that the HHSD Director is authorized to submit an application, on behalf of the County of Yuba, for the THP Round 3 allocation and any subsequent funds allocated.

BE IT FURTHER RESOLVED by the Yuba County Board of Supervisors that the HHSD Director is authorized to: execute, subject to review and approval of County Counsel, all documents as required by the application and the resultant allocation for the term of July 1, 2021 through June 30, 2024; execute agreements, memorandums of understanding (MOUs) or amendments developed according to the terms of the THP Round 3, including but not limited to amendments for additional or lesser funding; and accept, transfer and allocate all THP Round 3 funds and any subsequent funds allocated for the stated period.

A copy of the executed agreement, MOU or any amendment thereto shall be filed in the office of the Clerk of the Board.





Transitional Housing Program Allocation Acceptance Resolution

A RESOLUTION AUTHORIZING APPLICATION FOR AND ACCEPTANCE OF THE
COUNTY ALLOCATION AWARD UNDER THE TRANSITIONAL HOUSING PROGRAM

WHEREAS, the State of California, Department of Housing and Community Development (“Department”) issued an allocation acceptance form, dated October 1, 2021 under the Transitional Housing Program (“THP” or “Program”) for \$8 million authorized by item 2240-102-0001 of section 2.00 of the Budget Act of 2021 (Chapter 69 of the Statutes of 2021) and Chapter 11.7 (commencing with Section 50807) of part 2 of Division 31 of the Health and Safety Code (the “Allocation Acceptance Form”).

WHEREAS, the Allocation Acceptance Form relates to the availability of the funds under the Program; and

WHEREAS, the County of Yuba was listed as an eligible applicant in the Allocation Acceptance Form, dated October 1, 2021.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Supervisors for the County of Yuba (“County”) does determine and declare as follows:

SECTION 1. That County is hereby authorized and directed to apply for and accept County's allocation award, as detailed in the Allocation Acceptance Form (the “THP Allocation Award”), up to the amount authorized the Allocation Acceptance Form and applicable state law.

SECTION 2. That if funds remain available for allocation after the deadline for submitting a signed Allocation Acceptance Form, and if the Department advises County that County is eligible for an additional allocation from these remaining funds, County is hereby authorized and directed to accept this additional allocation of funds (“Additional THP Allocation”) up to the amount authorized by Department.

SECTION 3. That the Yuba County Health and Human Services Department (YCHHSD) Director, or his or her designee, is hereby authorized and directed to act on behalf of County in connection with the THP Allocation Award and any Additional THP Allocation, and to enter into, execute, and deliver any and all documents required or deemed necessary or appropriate to be participate in the Program, including but not limited to a Standard Agreement, and be awarded the THP Allocation Award, and any Additional THP Allocation, and any amendments to such documents (collectively, the "THP Allocation Award Documents").

Be it further resolved by the Yuba County Board of Supervisors that the YCHHSD Director or his or her designee is hereby authorized to: execute, subject to review and approval of County Counsel, any and all documents as required by the HNP allocation for the period of July 1, 2021 through June 30, 2024; execute agreements, memorandums of understanding (MOUs) or amendments developed in compliance with the HNP, including but not limited to amendments for additional or lesser funding; and accept, transfer and allocate all HNP funds and any subsequent funds allocated for the stated period. A copy of the executed agreement, MOU or any amendment thereto shall be filed in the office of the Clerk of the Board.

That County shall be subject to the terms and conditions that are specified in the THP Allocation Award Documents, and that County will use the THP Allocation Award funds and any Additional THP Allocation funds in accordance with the Allocation Acceptance Form, the THP Allocation Award Documents, and any and all other THP requirements, and other applicable laws.


