WHEREAS, on July 13, 2021, the Board of Supervisors of the County of Yuba adopted Resolution number 2021-097 formally adopting the Classification System – Basic Salary / Hourly Schedule effective July 1, 2021; and

WHEREAS, the Board of Supervisors now intends to amend Resolution No. 2021-097, regarding the Extra Help Classification System Hourly Schedule as it relates to the state statute increasing the minimum wage to \$15 per hour effective January 1, 2022; and

WHEREAS, the extra help classifications impacted by the minimum wage increase include Aide, Intern, General Worker, Reserve Correctional Officer, and Reserve Deputy Sheriff Level III; and

WHEREAS, the Board of Supervisors now intends to amend Resolution No. 2021-097, regarding the class of Supply/Mail Clerk on the Classification System - Basic Salary/Hourly Schedule, as it relates to the state statute increasing the minimum wage to \$15 per hour effective January 1, 2022.

NOW THEREFORE, BE IT RESOLVED, by the Board of Supervisors of the County of Yuba, that Resolution number 2021-097 be and hereby is amended as it relates to the Supply Mail Clerk class and extra help classifications impacted by the minimum wage increase.
