WHEREAS, Administrative Services applied for a grant through the Board of State and Community Corrections (BSCC), for emergency relief funds due to the Coronavirus health pandemic; and

WHEREAS, allowable projects and purchases, as determined by the BSCC, include but are not limited to addressing the medical needs of inmates and detainees, procurement of personal protective equipment for medical or law enforcement personnel, reimbursement for first responder overtime or hiring, training or travel, as well as additional supplies necessary to keep operation areas sanitized; and

WHEREAS, Administrative Services desires to utilize this funding to procure and install ionization systems in the existing air handler units at the Yuba County Jail and the current Juvenile Detention Facility, which will greatly reduce the risk of airborne viruses and allow for purified airflow throughout the facilities; and

WHEREAS, the Department of Administrative Services requested an extension to the contract duration to accommodate release of funds, procurement lead-times, and installation of ionization systems that are compatible with current HVAC units to not only reduce the risk of airborne viruses and bacteria, but also purify air to enhance overall quality, to include dust, droplets, particles, smoke, and other variants that can impact general quality of health; and

WHEREAS, the Board of State and Community Corrections granted an additional one year period to accommodate release of funds, procurement lead-times, and installation of ionization systems, extending the term of the agreement through January 2023.

NOW, THEREFORE, BE IT RESOLVED that the Yuba County Board of Supervisors hereby approves extension of the schedule and agreement terms through January 2023, and authorizes the County Administrator to execute Amendment 1, subsequent forms, and any additional documentation necessary, subject to approval by County Counsel.


