WHEREAS, in 2019, the Board of Supervisors authorized and executed the Rubrik Software Support Services Policy for implementation of software and subscription, which supports data recovery and backup for the software and appliances throughout the County facilities; and

WHEREAS, the Information Technology Team with Administrative Services has been working with ePlus Technology for many years to protect against data loss, and allow the county to recover from potential disasters, or unforeseen events; and

WHEREAS, continuing the subscription with Rubrik for support services and data backup and recovery will ensure county operations maintain stability and efficiency, regardless of circumstance; and

WHEREAS, the county’s Contract and Purchasing Policies Manual states that emergency purchases can be made when unforeseen circumstances require an immediate purchase in order to avoid a substantial hazard to life, or property, or serious interruption of the operation of a county department; and

WHEREAS, the Purchasing Agent executed purchasing documents, utilizing a cooperative agreement through the State of California’s Multiple Award Schedule (CMAS) in order to maximize savings on such subscription and premium support services; and

WHEREAS, the Yuba County Contract and Purchasing Policies Manual Section 1.2.5(b) further states that any acquisition of goods, or services, of \$15,000, or greater must be submitted by the responsible department for ratification at a regularly scheduled Board meeting within 30 days from date of purchase.




