**WHEREAS**, in June of 2020 the County of Yuba submitted an application to the State of California Department of Housing and Community Development Department (HCD), and has been approved to receive a funding allocation of \$1,000,000.00, to commence a CDBG Owner-Occupied Housing Rehabilitation Program, under the 2019-2020 CDBG funding year; as authorized by Resolution No. 2020-34, dated March 24, 2020.

**WHEREAS**, the County of Yuba, a political subdivision of the State of California, wishes to submit a request to the State of California to receive and commit an allocation of CDBG Program Income funds, up to the aggregate amount of \$915,000.00, to the CDBG Owner-Occupied Rehabilitation Program application; and

**WHEREAS**, CDBG Program Income funds accrue as a result of repayment of CDBG loans, which are governed by the Department of Housing and Community Development; and

**WHEREAS**, pursuant to CDBG regulations, the public has been invited to comment on the commitment of "CDBG Program Income" during a noticed public hearing, as well as to submit written comments; and

**WHEREAS**, should the request to commit CDBG Program Income funds be approved, the Director of Community development and Services Agency, or designee\* is authorized to act on the County's behalf to execute and deliver all documents pertaining to said CDBG program application, as stated in Resolution No. 2020-34, dated March 24, 2020.

**NOW, THEREFORE, BE IT RESOLVED**, the Yuba County Board of Supervisors hereby declare:

*Section 1.* That the above recitals are all true and correct; and

*Section 2.* That the County Board of Supervisors has reviewed and hereby approves the submission of a request to commit CDBG Program Income funds to the State of California, in the aggregate amount up to \$915,000.00, to increase funding available for the CDBG Owner-Occupied Rehabilitation Program, pursuant to the January 2020 CDBG NOFA; and

*Section 3.* That the County of Yuba acknowledges compliance with all state and federal regulation governing the use of CDBG Program Income funds; and

*Section 4.* The County of Yuba acknowledges compliance with all state and federal public participation requirements in the development of its application(s); and

*Section 5.* This Resolution shall take effect upon its adoption.






