WHEREAS, the American Automobile Association (AAA) has made car seat donation program funds available through the Child Passenger Safety Donation Program for the purpose of purchasing car seats, booster seats, and/or for car seat check-up events; and

WHEREAS, it is in the best interest of its residents of the County of Yuba to apply for and utilize the program funds for the purchase of car seats and booster seats to be used during car seat check-up events, particularly for those residents who are the most vulnerable population within the County of Yuba.

NOW, THEREFORE, BE IT RESOLVED by the Yuba County Board of Supervisors that the Health and Human Services Department (HHSD) Director is authorized to submit an application to AAA for the 2022 Child Passenger Safety Donation Program for an anticipated amount of \$5,000.

BE IT FURTHER RESOLVED by the Yuba County Board of Supervisors that the HHSD Director is hereby authorized to: execute, subject to review and approval of County Counsel, all documents as required by the application and the resultant program for the stated period; amend contracts for additional or lesser funding; execute agreements, amendments or memorandums of understanding (MOUs)

developed under this program if the allocation, or a portion thereof, is awarded; and accept, transfer and allocate the program funds for the period of January 1, 2022 through December 31, 2022. A copy of said agreements, MOUs or any amendments thereto shall be filed in the office of the Clerk of the Board, County of Yuba, after they have been reviewed and approved by County Counsel and executed by the HHSD Director.


