RESOLUTION NO. 2022-39

WHEREAS, the California Film Commission encourages local communities to establish local film commissions to attract and encourage motion picture, television, and commercial filming and photography to their areas; and

WHEREAS, to assist in that endeavor, a local film commission can be recognized as a Regional Film Partner with the California Film Commission, and

WHEREAS, the California Regional Film Partnership is a network of local film offices and commissions that work cooperatively with the California Film Commission to retain, attract, and facilitate film production; and

WHEREAS, a local film commission that is recognized by a local government and by the California Film Commission as a Regional Film Partner can also join Film Liaisons in California Statewide (FLICS), a non-profit professional membership association that can provide production support; and

WHEREAS, the motion picture, television, commercial filming, and photography industry is underdeveloped locally and has the potential to contribute to Yuba County’s economy, and

WHEREAS, the Upstate California Film Commission, is a collaborative partner with the Yuba Sutter Chamber of Commerce; and


WHEREAS, it is in the best interest of Yuba County to attract and encourage motion picture, television, commercial filming, and photography opportunities to Yuba County by association with the Upstate California Film Commission, California Film Commission, and FLICS.

NOW, THEREFORE, BE IT RESOLVED that the Yuba County Board of Supervisors

1. Recognizes the Upstate California Film Commission to serve as the Yuba County Film Commission;
2. Recognizes the Upstate California Film Commission, serving as the Yuba County Film Commission, as the County of Yuba's Regional Film Partner with the California Film Commission;
3. Recognizes the Upstate California Film Commission, serving as the Yuba County Film Commission, as the County of Yuba's liaison to FLICS;
4. Authorizes the Upstate California Film Commission to serve as the County of Yuba's representative to the film industry in providing location services and promoting Yuba County as a film location; and
5. Generally supports the efforts of the Upstate California Film Commission serving as the Yuba County Film Commission, but is not committed to any particular action in any particular situation.


